The State of Texas requires a "just and equitable" division of property. A 50/50 settlement is rarely appropriate and should never be implemented

without expert advice and ideally, using a financial evaulation of the situation by a Certified Divorce Financial Analyst. The division of marital assets in a divorce should take into account the need for one spouse to receive sufficient assets to provide support considering the much higher earnings of the other party.
